YOU NEED TO KNOW YOUR RIGHTS

ALL VICTIMS OF CRIME IN NEVADA HAVE THE FOLLOWING RIGHTS
(NEVADA STATE ATTORNEY GENERAL'S OFFICE)

- To know the status of the case in which you are involved.
 - To be free from intimidation or dissuasion.
- To know when your impounded property may be released.
- To receive a witness fee for lawful obedience to a subpoena.
- To understand the existing victim compensation laws and receive compensation if applicable.
- To a secure waiting area, which is not available to the defendant or his family, when you are at court.
- To know when the defendant is released from custody before or during trial (upon written request).
- To know when the offender is released from prison (upon written request).

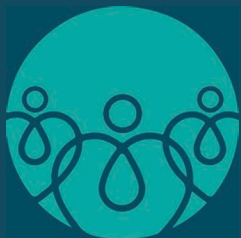

TODAS LAS VÍCTIMAS DE DELITOS EN NEVADA TIENEN LOS SIGUIENTES DERECHOS (LA OFICINA DEL PROCURADOR GENERAL DE NEVADA)

- De saber el estado del caso en cual está involucrado
- De ser libre de intimidación o disuasión
- De saber cuándo su propiedad confiscada será liberada
- De recibir una tarifa de testigo por obediencia legal a una citación.
- De comprender las leyes de compensación de víctimas existentes y recibir compensación si corresponde.
- A un área de espera segura, que no está para el acusado o su familia, cuando usted está en la corte.
- De saber cuándo el acusado será liberado de custodia antes o durante el juicio (solicitud por escrito)
- De saber cuándo el acusado será liberado de prisión (solicitud por escrito)
